

Measures of the Dean of the FHSS USB no. 13/2016

The rules for the second round of admission process and the conditions for admission into the academic year 2016/2017 of the Bachelor study program offered in English language

Article I. General provisions

Based on the § 48 - § 51 and § 58 par. 1 of the Act No. 111/1998 Coll. on universities and on changes and amendments to other acts (the Universities Act), hereinafter referred to as the Higher Education Act and the Article 6 - 12 of the Constitution of the University of South Bohemia in the České Budějovice I am announcing the rules for the admission procedures and conditions for admission to the Bachelor's study program taught in English on the Faculty of Health and Social Sciences of the University of South Bohemia in the České Budějovice for the academic year 2016/2017.

Article II. Opening of the study courses

1. In the academic year 2016/2017 the Faculty of Health and Social Sciences of the University of South Bohemia in České Budějovice will open:
Study program **Nursing** (B 5341), study course **Nurse** (5341R009) – three – year full – time Bachelor study program.
2. Number of applicants accepted:
Study program **Nursing**, study course **Nurse** full – time study: 10
3. Tuition fee for one semester of the Bachelor study program is 1.100, - EUR for students from the European Union and 1.600, - EUR per semester for students from countries outside the European Union.

The prospective student will receive instructions on payment of the tuition fee simultaneously with the decision on admission. Tuition fees must be paid no later than on the day of the enrolment.

Article III. Guidelines for submission of applications

1. Application submission deadline: **June 30, 2016**
2. The prospective student can apply to the Bachelor study program Nursing, study course Nurse by:
 - Submitting a filled – in and signed application form which is in Annex no.1 (to be completed in English language)
 - Submitting mandatory annexes of the application form, which are:
 - A certified true copy of your passport and birth certificate

- A certified true copy of an official document confirming the completion of high school education.

Should the Application form and the mandatory annexes thereof have any formal deficiencies, they shall be returned to the prospective student for revision. Should the prospective student fail to correct the deficiencies in the given deadline, he/she has not met the minimum condition for admission.

Article IV. Admissions

1. Those candidates who have sent all the mandatory materials will be included in the admission procedure. A part of the admission procedure will be a personal interview, which will focus on:
 - Motivation for learning;
 - Nurse as a profession and health care;
 - Knowledge of the English language.

The candidate may receive a maximum of 100 points (20 points from the motivation interview, 40 points of knowledge on nurse as a profession and health care and 40 points from knowledge of English language).

2. The admissions committee will establish the order of candidates suitable for admission. The Dean of the Faculty decides on the acceptance of the applicant based on the recommendation of the admissions committee within 8 days of the interview and according to § 50 par. 5 of the Higher Education Act the applicant is informed on the outcome in writing within 30 days.
3. Term of the admission procedure: **4 - 11 July 2016**

Article V. Final Provisions

Conditions of the admission procedure were discussed and approved by the Academic Senate of the Faculty of Health and Social Sciences of the University of South Bohemia in České Budějovice on 13 June 2016.
